# Soccer Nights Crew FAQ

## 1. Who can apply for Soccer Nights Crew?

All youth going into 8th to 10th grade who are interested in helping at Soccer Nights and learning leadership skills.

## 2. When is the application due?

The application is due on Tuesday, June 17th. **No** late applications will be accepted.

## 3. How do I submit my application?

You can submit your application 3 different ways:

## 4. Do I have to come to the interview and training?

Yes. It is on Thursday, 6/19 in the evening at the Vineyard church, 170 Rindge Ave.

## 5. What are you looking for in a Crew applicant?

During the interview, we are looking for youth who are:

- 1) **Committed.** Able to attend Crew time and volunteer every day (June 23rd-27th).
- 2) **Passionate.** Excited about Soccer Nights and think it's awesome!
- 3) **Eager to learn.** Willing to receive training and feedback to be a great helper.

## 6. What will we be doing from 4-9:30 everyday?

4-5:30pm is Crew time: free pizza dinner, play games, and practice leadership skills.

5:30-9:30pm is the Soccer Nights program: helping in a specific role.

## 7. What are the different volunteer positions I can apply for?

**Coach:** Coach a team of 8-12 kids to be better soccer players. Run drills and scrimmages.

**Registration:** Check kids or volunteers in and out, sell t-shirts, cut and pass out snacks.

**Logistics:** Set-up and tear-down the field, supply teams with water and other supplies.

**3 to 5 year olds:** Run activities with 3-5 year olds such as mini soccer games, coloring, and face painting.

## PARENTAL CONSENT & LIABILITY FORM

2. In consideration of the opportunity for my child to participate in Soccer Nights and other Vineyard Community Offerings and Schochet Companies initiatives, I agree to hold harmless and indemnify the Vineyard Christian Fellowship-- Greater Boston, Cambridge Community Fellowship Church, Pentecostal Tabernacle, the City of Cambridge, the City of Medford, the City of Malden, the Cambridge Police Department, the Schochet Companies ("Fresh Pond Apartments"), Redemption Hill Church, and Seven Mile Road Church, and their employees, volunteers, agents, successors, heirs, estates, executors, administrators, and assigns from any and all claims, demands, actions, damages, and liabilities whatsoever which may directly or indirectly result from or be related to any loss, damage, or injury that may be sustained by my child or sustained by any other person or property, in connection with my child's participation in Soccer Nights and other Community Offerings and Schochet Companies initiatives.

I further agree to release and forever discharge the Vineyard Christian Fellowship-- Greater Boston, Cambridge Community Fellowship Church, Pentecostal Tabernacle, the City of Cambridge, the City of Medford, the City of Malden, the Cambridge Police Department, the Schochet Companies ("Fresh Pond Apartments"), Redemption Hill Church, and Seven Mile Road Church, their employees, volunteers, agents, successors, heirs, estates, executors, administrators, and assigns from all such claims, demands, actions, damages and liabilities whatsoever, which I may have, on behalf of my child whether foreseen or unforeseen, on account of my child's participation in Soccer Nights and other Vineyard Community Offerings and Schochet Companies initiatives.
4. This release and discharge shall be binding upon the successors, heirs, estates, executors, administrators, and assigns of the undersigned.

I certify that, to the best of my knowledge, my child has no medical, psychological, or physical conditions that could interfere with his or her safety in Soccer Nights or other Vineyard Community Offerings and Schochet Companies initiatives activities and that I am willing to assume and bear the costs of all risks that may be created, directly or indirectly, by any such condition.

In the event of illness or injury, I hereby authorize representatives of the Vineyard Christian Fellowship-- Greater Boston, Cambridge Community Fellowship Church, Pentecostal Tabernacle, the City of Cambridge, the City of Medford, the City of Malden, the Cambridge Police Department, the Schochet Companies ("Fresh Pond Apartments"), Redemption Hill Church, and Seven Mile Road Church, to act for me according to their best judgment in any emergency requiring immediate medical attention, and hereby grant the right to take appropriate action for my child's health and safety and to obtain any necessary medical assistance.
